You are invited to participate in the 26th annual Art in the Park Festival, located in Brooksville's beautiful Tom Varn Park. This festival, held during the "end of the Florida show season" is a favorite with Florida Artists and Art-Show fans alike.

Our host location, Tom Varn Park, is located at 306 Darby Lane, Brooksville, FL 34601. (just off SR-50A/Jefferson Street) You'll find Brooksville about 40 miles north of Tampa. Many returning artists tell us this is their favorite show, partly due to the beautiful, shady setting. There's plenty of parking and rest room facilities.

- Hernando County is home to many artists and craftspeople.

Art in the Park is presented by the Hernando County Fine Arts Council and sponsored by the City of Brooksville, Hernando County Tourist Development Council, and the Florida Cultural Alliance.

The mission of the Hernando Fine Arts Council is to encourage, promote & support all the creative arts in Hernando County and provide a means to showcase the arts.

### RULES

1. Artist must exhibit and be present during the entire show. Failure to follow this rule makes the artists ineligible for prizes and admission to future shows.
2. Only Fine craftsmen and artists displaying their own original work may participate. All works must have been produced within the past four years. Paintings reproduced from works of masters, from advertisements, and from widely circulated photographs are not considered original works of art and may not be displayed or sold. All work must be attributable solely to the displaying artist.
3. Picture frames, velvet paintings, manufactured or kit jewelry, ceramics cast from commercial molds, art supplies, commercial displays, decoupage **ARE NOT ELIGIBLE TO BE EXHIBITED.**
4. Exhibitors are responsible for collecting 6 1/2% sales tax.
5. Artists **MUST PROMINENTLY** display the ID card provided by the Committee showing name, city of residence, space #, and medium.
6. The Committee reserves the right to ask the artists not complying with these rules to remove their exhibit from the show area with forfeiture of all fees. All displays shall be neat and orderly, tables skirted and all items not for sale, out of sight.
7. Exhibitors may not display ribbons or awards from other shows.
8. All awards are given at the discretion of the judges. Judging will begin at 10 AM, Saturday. Judging results and ribbons will be given on Saturday afternoon. All judges' decisions are final. Cash awards are distributed on Sunday. Artist must be present to receive award.
9. ANIMAL/PETS ARE NOT PERMITTED IN THE PARK PER CITY OF BROOKSVILLE ORDINANCE.
10. Upon arrival, artists **MUST CHECK IN** to receive their booth assignments. Spaces are pre-assigned and ARE FINAL. Set up time is 1-6 PM Friday and 7:00-9:00 AM Saturday. All booths must be set up by 9:00 AM Saturday and vehicles parked in **APPROVED** parking spaces or **they will be towed at owner's expense.** For the convenience of all, please unload your vehicle and move to the approved parking area as quickly as possible. Coffee and pastry will be available at no charge on both days until 9:00 AM.
11. Handicapped or special needs must be identified on the application form.
12. Booth spaces are 10 X 10. Electricity and water **are not** available at the booth.

### APPLICATION INSTRUCTIONS

1. Application fee schedule:  
\$115 if application is postmarked by March 19th  
\$150 if application is postmarked between March 20th and April 10th. This is a juried show, all booths will be judged. Application deadline is April 10, 2010.
2. Acceptance/rejection letters will be mailed within two weeks of receipt or no later than April 17th for applications received by April 10th.
3. A total of three photos representative of the work you will be displaying are required. Only clear, close up photos will be accepted. Photos must be labeled with:
  - a. an arrow indicating the top of the photo
  - b. name and phone number
  - c. medium
  - d. price point
4. Only artists and craftsmen displaying their own original work may participate. Separate applications and fees must be supplied for each category entered by an artist. Only one category will be judged in a booth.
5. Electrical hook-up available at the following rates: 115V @ \$25 or 220V @ \$40. You must provide your own extension cord.
6. Applications **MUST** include a self-addressed #10 business envelope with sufficient postage.
7. Any invalid check must be validated to include an additional \$32 insufficient funds charge.

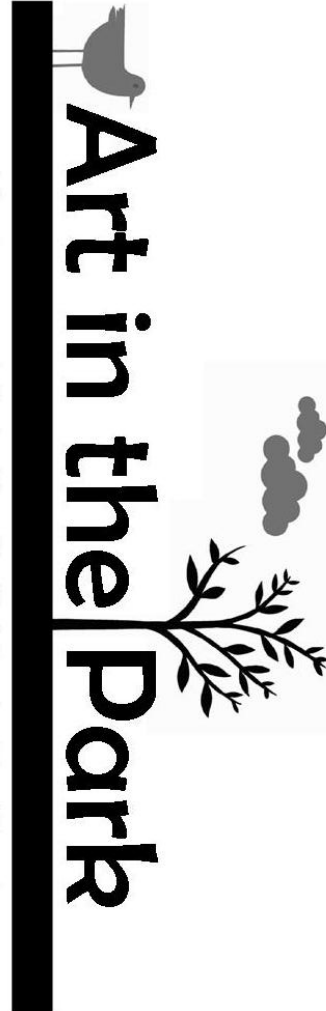
